Application are invited from eligible candidates for appointment as Specialists in AR Composite Hospital, Shukhovi and GDMO (General Duty Medical Officers) in AR Hospitals on Contractual Basis as per the terms & conditions mentioned below :-

1 **Date & place of Interview**-Will be intimated to candidates by post & Telephone.

2 **Remuneration** Specialist Doctors Rs 85,000/- per month and General Duty Medical Officer Rs 75,000/- per month

3. **Age** Not more than 67 yrs (Please also refer para 6 below)

4. **Educational & Professional Qualifications**

(a) **Specialist Doctors**

(i) A recognized medical qualification included in the first or Second Schedule or Part II of the Third Schedule (Other than that licentiate qualifications) to the Indian Medical Council Act,1956. Holders of educational qualifications included in Part II or the Third Schedule should also fulfill the conditions stipulated in sub-section (3) of section (13) of the Indian Medical Council Act,1956.

(ii) Post Graduate Degree/Diploma in the concerned Speciality as mentioned in Section-A or Section-B of Schedule-VI or equivalent.

(iii) 1Years 06 months experience for Post Graduate Degree holders & 2Years 06 months for Diploma holder in the concerned specialty after obtaining the Post Graduate Degree/ Diploma or equivalent.

(b) **General Duty Medical Officer** A recognized medical qualification included in first or Second Schedule or Part II of Third Schedule (Other than that licentiate qualification) to Indian Medical Council Act,1956. Holders of educational qualifications included in Part II or Third Schedules should also fulfill conditions stipulated in sub-Sec (3) of Sec (13) of the Indian Medical Council Act,1956 & Completion of compulsory rotational internship.

(c) **Dental Surgeon** A Degree(Bachelor of Dental Surgery) from a recognised University/ Institution included in the sch to the Dentists Act, 1948 (16 of 1948) (ii) Should be registered with Dental Council of India.

5. **Medical Examination** Immediately after interview on the same day candidates will be medically examined by Board of Medical Officers detailed by concerned Composite Hospital. Appointment will be subject to medical fitness.

6. **Period of Contract** Initial Contractual Appointment will be for 3 years or till regular incumbent joins. Contract may be extended for further 2 years on year to year basis subject to the maximum age cap of 67 years. Total period of Contract will be five years or till the appointee attains the age of 67 years.

Thereafter, the contract will lapse automatically, However, the appointment can be terminated at any time by giving one month notice (on either side) without assigning any reasons by paying/refunding one month salary.

7. No Extension beyond the stipulated five years will be given. However, there is no bar on a contractual appointee applying afresh on completion of 5 years..

8. **Entitlement of Leave** 30 days per year for the appointee.

9. The appointee shall not have any claim or right to regular appointment to any post under CAPFs.

10. The appointee shall be on whole time appointment of the institution & shall not accept any other appointment, paid or otherwise, during the period of contract.
